The franchise offered is for the establishment and operation of a casual restaurant offering high-quality pizza, calzones, sandwiches, wraps, salads and pastas prepared to order and served quickly for dine-in or carry out customers.

We offer 2 franchise programs:

A single Rotolo's Pizzeria restaurant. The total investment necessary to begin operation of a Rotolo's Pizzeria franchise is \$290,710 to \$613,720. This includes \$35,000 that must be paid to the franchisor or affiliate. The franchise fee for multiple unit developers is \$20,000 for the first franchise and \$20,000 for each additional unit.

Multiple Rotolo's Pizzeria restaurants. The estimated total investment necessary to begin operation of multiple Rotolo's Pizzeria franchises ranges from \$295,710 to \$688,720 (but can be more if you choose to develop more than 10 units). The initial development fee ranges from \$20,000 (to develop 2 additional franchises) to \$90,000 (to develop 10 total franchises) or higher for the development of more than 10 units.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN LOUISIANA THAN IN YOUR HOME STATE.
2. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT STATE THAT LOUISIANA LAW GOVERNS THE AGREEMENTS, AND LOUISIANA LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
