The estimated total investment necessary to begin operations for a dine-in ROUND TABLE® Pizza restaurant ranges from \$409,500 to \$757,750. This includes \$25,000 that must be paid to the franchisor or affiliate. The estimated initial investment necessary to begin operations for a ROUND TABLE® Pizza restaurant that provides only delivery and carry-out service is \$263,800 to \$437,250. This includes \$25,000 that must be paid to the franchisor or affiliate. These amounts do not include any area development fee.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
