The estimated total investment necessary to begin operations for a dine-in ROUND TABLE® Pizza restaurant ranges from \$409,500 to ~~\$757,750~~786,250. This includes \$25,000 that must be paid to the franchisor or affiliate. The estimated initial investment necessary to begin operations for a ROUND TABLE® Pizza restaurant that provides only delivery and carry-out service is ~~\$263,261,800~~ to ~~\$437,438,250~~. This includes \$25,000 that must be paid to the franchisor or affiliate. The estimated initial investment necessary to begin operations for a ROUND TABLE® Clubhouse restaurant is 428,500 to \$828,250. This includes \$25,000 that must be paid to the franchisor or its affiliate. These amounts do not include any area development fee.
