The franchisee will operate an RSVP® direct mail service advertising business. The total investment necessary to begin operation of an RSVP Business ranges from \$44,400 to \$176,000 or more. This includes \$30,000 to \$120,000 or more, depending on the size of the Territory the franchisee purchases, that must be paid to the franchisor.
