The Franchisee will operate a hairstyling salon performing haircutting and other related services, and the retail sale of professional salon products.

The initial franchise fee is \$20,000.00. The estimated initial investment required, including the franchise fee, ranges from in excess of \$169,300.00 to in excess of \$251,300.00. This is only an estimate. This includes the current initial franchise fee paid to us of \$20,000.00 and \$3,000.00 in opening advertising which is paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale or grant. The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Real all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or accountant.
