We offer two types of franchises: 1) a single Unit Franchise(s); and 2) a Regional Developer franchise(s). We are offering the right to operate a Unit franchise under this Disclosure Document. Each Unit Franchise will conduct business under the trademark RX2Live™ and/or such other trademarks that we authorize from time to time (“the Marks”). Unit Franchises will own and operate businesses specializing in offering and providing a wide range of medical products and services to healthcare professionals, along with weight loss and wellness products and services to the general public.

The estimated total initial investment necessary to begin operations of your Unit Franchise will range from **\$56,300 to \$89,747**. This amount includes an Initial Franchise Fee of **~~\$39,900~~ \$39,900**, and other fees of **approximately \$1,600**, that must be paid to the franchisor or an affiliate.

This disclosure document (“Disclosure Document”) summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully.
