Safe Ship® businesses are full service mail sorting, handling, receiving, packing, shipping, storage and transportation facilities featuring mail, freight, parcels, packages, regular delivery and overnight delivery by ground and air carriers, packing, shipping, mail boxes, copying, printing, business services and other goods and services.

The total investment necessary to begin operation of a Safe Ship® franchised business is \$148,800. This includes \$94,800 that must be paid to the Franchisor or its affiliates. This includes the franchise fee of \$19,900. We require a deposit against the franchise fee of \$5,000 when you sign the Deposit Agreement, which is Appendix "B" of our Franchise Agreement. The buildout package is \$74,900 and is payable to us at the time you request us to assist you to look for a location for your Store. The buildout package covers leasehold improvements, equipment, furniture, supplies, computer equipment, software and inventory.

You may qualify for a single, one-time-only \$5,000 credit against the \$19,900 franchise fee if you or your spouse is on active duty or are a veteran honorably discharged from the US armed forces.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however that no government agency has verified the information contained in this document**.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
