The franchisee will operate a "Sahara Pizza" casual restaurant (the "Restaurant"). A "Sahara Pizza" is a delivery and casual dining pizzeria offering delivery for dinner and evening, and for lunch in certain markets; casual helpful service; high-quality specialty gourmet pizza items, and moderate prices that encourage regular return orders.

The estimated initial investment for the Restaurant required ranges from \$52,300 to \$168,500 (See Items 5, 6, and 7 below). This includes the total amount in Item 5 that must be paid to us. The initial franchise fee is \$5000 for a term of ten years.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or accountant.
