As a franchisee, you will operate a fast casual restaurant offering a menu specializing in freshly prepared salads, soups, wraps and dressings under the marks "Salata."

The total investment necessary to begin operation of a Salata restaurant franchise is from \$375,500 to \$497,500 for a traditional in-line shopping center site, and \$248,000 to \$380,750 for a business district/non-traditional site. This includes the initial franchise fee of \$30,000. Also included is approximately \$3,000 to \$4,000 paid to our affiliate for certain proprietary products representing a portion of your initial inventory of food, as well as up to approximately \$0 to \$13,500 paid to us as a construction fee. Please see Items 5, 7 and 8 for additional details.

We may offer to enter into an area development agreement to establish and operate a certain number of Salata restaurants at specific locations pursuant to individual franchise agreements. The area development fee will be equal to \$15,000 multiplied by the number of Salata restaurants to be developed under the area development agreement. The area development fee will then be credited, in increments of \$15,000, toward the franchise fee owed for each Salata restaurant developed. Your estimated initial investment will vary based on the number of restaurants to be developed.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive the Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

IT MAY ALSO COST MORE TO ARBITRATE OR LITIGATE WITH THE FRANCHISOR IN TEXAS THAN IN YOUR HOME STATE.
