As a franchisee, you will operate a fast casual restaurant offering a menu specializing in freshly prepared salads, soups, wraps and dressings under the marks “Salata ”

The total investment necessary to begin operation of a Salata restaurant franchise is from \$578,350 to \$828,500 for a traditional in-line shopping center site, and \$279,000 to \$431,000 for a business district/non-traditional site This includes \$55,000 to \$62,000 that must be paid to us as the franchisor our affiliate

We may offer to enter into an area development agreement to establish and operate a certain number of Salata restaurants at specific locations pursuant to individual franchise agreements The area development fee will be equal to \$20,000 multiplied by the number of Salata restaurants to be developed under the area development agreement The area development fee will then be credited, in increments of \$20,000, toward the franchise fee owed for each Salata restaurant developed Your estimated initial investment will vary based on the number of restaurants to be developed For each Salata restaurant developed under an area development agreement the cost is from \$404,500 to \$655,000 for a traditional in-line shopping center site, and \$279,000 to \$431,000 for a business district/non-traditional site This includes \$43,000 to \$44,000 that must be paid to us as the franchisor our affiliate

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English Read this Disclosure Document and all accompanying agreements carefully You must receive the Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale **Note, however, that no government agency has verified the information contained in this document**

OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE OR LITIGATE WITH THE FRANCHISOR IN TEXAS THAN IN YOUR HOME STATE.

- 4 THE FRANCHISE AGREEMENT CONTAINS PROVISIONS THAT LIMIT FRANCHISEE'S RIGHTS AND MAY NOT BE ENFORCEABLE IN CALIFORNIA INCLUDING BUT NOT LIMITED TO A TIME LIMIT TO RAISE CLAIMS AGAINST THE FRANCHISOR, LIMITATION OF DAMAGES AND WAIVER OF JURY TRIAL.
- 5 THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source is our agent and represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
