3. YOU MUST PAY US A MINIMUM ROYALTY FEE OF \$2,500 ON A QUARTERLY BASIS EVEN IF THE FRANCHISE HAS NO REVENUE.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
