The Franchise Business you will own and operate is a business offering dog walking, pet sitting and dog boarding services under the trade name "Saving Grace Pet CareSM.

The total investment necessary to begin operation of a Franchise Business ranges from \$20,800 to \$41,650. This includes \$12,500 to \$19,500 that must be paid to us or our affiliate.

We also offer to certain qualified persons rights to develop a specified number of Franchise Businesses (the "Franchise Businesses") within a Development Area under a Saving Grace Pet Care Development Agreement. You must pay us a Development Fee equal to \$5,000 times the number of Franchise Businesses you agree to develop (other than for the first Franchise Business that you must purchase at the same time you purchase Development Rights). We will credit \$5,000 of the Development Fee against the Initial Franchise Fee for each Franchise Business you develop.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale or grant. **Note, however, that no governmental agency has verified the information contained in this Franchise Disclosure Document.**
