Savory Spice Shop businesses operate retail stores that offer a variety of seasonings and spices, original blends, extracts, sauces, spice ware and gift sets ("<u>SSS Businesses</u>").

The total investment necessary to begin operation of our standard SSS Business is between \$187,886 and \$394,153, including between \$45,675 and \$147,500 that must be paid to the franchisor or its affiliates. We also offer SSS Businesses that operate in larger retail spaces with expanded storage. The total investment necessary to begin operation of a larger SSS Business is between \$210,511 and \$434,653, including between \$56,300 and \$158,000 that must be paid to the franchisor or its affiliates. We also offer to those franchisees that qualify the right to operate a Savory Spice Stop business which operates in a smaller retail space and offers a limited selection of Savory Spice Shop products under the Savory Spice Stop name. The total investment necessary to begin operation of a Savory Spice Stop business is between \$138,011 and \$324,653, including between \$32,800 and \$129,500 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
