The franchise described in this Franchise Disclosure Document is for the operation of a coffee café that specializes in the sale of hot and cold coffees, tea and chai, gourmet pastries, bagels, muffins, fruit smoothies, soft drinks and other cold beverages, and related products and services under the "Saxbys Coffee" name and marks (the "Saxbys Coffee Café").

The total initial investment necessary to begin operation of a Saxbys Coffee Café franchised business ranges from \$229,750 to \$410,500, which includes \$42,000 to \$60,000 that must be paid to franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.** You may wish to receive your disclosure document in another format that is more convenient for you.
