SCA APPRAISAL SERVICES

The franchisee will operate an SCA Appraisal Services business, which provides vehicle property damage appraisal services for insurance companies.

The total investment necessary to begin operation of a SCA Appraisal Services business is from \$29,300 to \$37,450. This includes the \$10,000 initial fee that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of you contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or accountant.
