FRANCHISE DISCLOSURE DOCUMENT

You will operate a Schlotzsky's® restaurant ("Restaurant"). Schlotzsky's® restaurants are bakery-cafe, quick casual restaurants featuring premium sandwiches, pizzas, soups and salads and complementary food and beverages. As a condition of granting you a Schlotzsky's® franchise, we also typically require you to purchase a Cinnabon® Express franchise to operate inside the Restaurant, except in rare instances involving non-traditional locations.

The total investment necessary to begin operation of a Schlotzsky's® franchise with a Cinnabon® Express franchise inside it ranges from \$503,814 to \$786,984 (\$358,449 to \$979,984 for a converted location). This total investment estimate includes \$37,500 that must be paid to us or to our affiliates. The total investment necessary to begin operation of a Schlotzsky's® Cafe Xpress restaurant with a Cinnabon® Express franchise inside ranges from \$42,064 to \$701,984 (\$272,564 to \$661,984 for a converted location). This includes \$37,500 which must be paid to us or to our affiliates.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

EVEN THOUGH THE FRANCHISE AGREEMENT PROVIDES THAT GEORGIA LAW APPLIES, LOCAL LAW MAY SUPERSEDE THIS REQUIREMENT IN YOUR STATE.
