

The franchise is for a restaurant featuring culturally specialized Korean "street style" food and a variety of related items. A prospective franchise may choose either to purchase (1) a full size "SCHOOL FOOD" franchise or (2) a scaled down "MINI SCHOOL FOOD" franchise. A SCHOOL FOOD franchise is a restaurant offering full scale menu while a MINI SCHOOL FOOD franchise will offer limited menu.

The total investment necessary to begin operation of a SCHOOL FOOD franchise is estimated to be between the range of \$219,000 and \$700,000. The total investment necessary to begin operation of a MINI SCHOOL FOOD franchise is estimated to be between the range of \$164,000 and \$672,000. These amounts include franchise fees of \$50,000 for a SCHOOL FOOD franchise and \$40,000 for a MINI SCHOOL FOOD franchise that must be paid to the franchisor or affiliate. These amounts exceed the Franchisor's stockholders equity as of December 31, 2012, which is \$12,379.00.
