As a Scooped Cookie Dough Bar franchisee, you will operate a fast-casual cookie dough shop.

The total investment necessary to begin operation of a Scooped Cookie Dough Bar Franchised Business ranges from \$94,300 to \$181,500. This includes \$29,900 which must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of an Area Development Business for three to five Franchised outlets is \$124,200 to \$241,300. This includes \$59,800 to \$89,700 which must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
