Scooter's Coffee, LLC, is offering franchises for the right to operate a quick service coffee store, or quick-serve coffee and yogurt store, offering drive-through, carry-out and in-store seating service of espresso drinks, smoothies, baked goods, frozen yogurt and other items under the service marks 'SCOOTER'S COFFEEHOUSE', 'SCOOTER'S COFFEE' and 'SCOOTER'S COFFEE & YOGURT' ("SCOOTER'S"). We also grant qualified persons, under our Area Developer Agreement, the right to solicit and refer to us qualified prospective franchisees and to provide ongoing supervision to our franchisees located in a particular geographic area.

Depending upon the type of store to be operated, the total investment necessary to begin operation of a SCOOTER'S franchise is between \$77,000 to \$445,500. This includes \$43,000 to \$55,000 that must be paid to the franchisor or an affiliate. Further information regarding the franchisee's anticipated investment can be found in Item 7 of this Disclosure Document.

If you execute a Multiple Store Development Agreement, the total investment necessary to begin operation of the appropriate number of SCOOTER'S franchises is between \$154,000 to \$890,000, for a two-store agreement, depending on the type of stores opened, with the investment increasing with the number of stores agreed upon. This includes \$86,000 to \$111,000 that must be paid to the franchisor or an affiliate.

If you execute an Area Developer Agreement, the total investment necessary to begin operation of the areadeveloper business is between \$224,000 and \$237,000. This includes \$200,000 for the Initial Area Development Fee and \$20,000 for the Initial Advertising Fee, both of which must be paid to the franchisor or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. - 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY LITIGATION AND ARBITRATION ONLY IN THE STATE OF NEBRASKA. OUT-OF-STATE LITIGATION AND ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE OR ARBITRATE WITH US IN THE STATE OF NEBRASKA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT NEBRASKA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THE FRANCHISE AGREEMENT DOES NOT PROVIDE FOR AN EXCLUSIVE TERRITORY.
- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
