You will operate an indoor, tropical-themed party and fitness facility for children and their families, using the "Scooter's Jungle" system and trademarks (a "Jungle").

The total estimated initial investment necessary to begin operation of a "Scooter's Jungle" facility ranges from \$474,950 to \$680,850 (see Item 7). This includes the initial fee that must be paid to us, which ranges from \$40,000 to \$45,000, depending upon the type of franchised business you operate (see Item 5). If your franchise business is, or includes, a Multi-Use Room or "Palace," the Initial Investment required will be approximately \$100,000 more than the range provided above.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
