As a franchise, you will operate a Scrambler Marie's Breakfast Bistro.

The total investment necessary to begin operation of a Scrambler Marie's Breakfast Bistro is \$368,000 to \$515,000. This includes \$25,000 (reduced to \$20,000 if you are in good standing and operating 4 or more Scrambler Marie's Breakfast Bistros) that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
