The franchise offered is to operate a business offering auditing services for bars, nightclubs, restaurants and other hospitality establishments to monitor the loss of liquor, wine and beer due to theft, spillage, shrinkage and other factors and the sale of a proprietary monitoring system designed to help hospitality establishments serve consistently excellent draught beer, all under the trade name <u>BevintelSculpture</u> <u>Hospitality</u> and other names, marks and commercial symbols we designate.

The total investment necessary to begin operation of your franchise in a territory consisting of approximately 150 hospitality establishments ranges from \$43,400 to \$47,100. This includes \$39,900 that must be paid to the franchisor or its affiliate(s). The total investment necessary to begin operation of your franchise in a territory consisting of approximately 250 hospitality establishments ranges from \$53,400 to \$57,100. This includes \$49,900 that must be paid to the franchisor or its affiliate(s).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale or grant.
