We offer a franchise to operate a Sears Home Appliance Showroom to sell to consumers a full assortment of branded home appliances and other merchandise and related products

The total investment necessary to begin operation of an existing Sears Home Appliance Showroom ranges from \$182,500 to \$1,013,000 This includes \$75,000 to \$775,000 that must be paid to the franchisor or its affiliates

The total investment necessary to begin operation of a new Sears Home Appliance Showroom ranges from \$177,500 to \$432,500 This includes \$27,500 to \$30,000 that must be paid to the franchisor or its affiliates

We also offer development opportunities for multiple Sears Home Appliance Showrooms In addition to your investment costs for the first Sears Home Appliance Showroom described above, the total investment necessary for development rights for additional Sears Home Appliance Showrooms equals the sum of (1) \$25,000 for the first Sears Home Appliance Showroom to be developed under the development agreement and (2) \$17,500 multiplied by the number of additional Sears Home Appliance Showrooms to be developed under the development agreement. We estimate that this sum will range from \$25,000 to \$77,500 This entire amount is payable to the franchisor or its affiliates
