The total investment necessary to begin operation of a SeekingSitters franchise ranges from \$39,500 to \$69,400. This includes the minimum of \$30,000 that must be paid to the franchisor or its affiliate, including the initial franchise fee. The initial franchise fee is \$25,000 for territories of up to 300,000 population plus an additional \$1,000 for each additional 100,000 population.
