The franchised business you will own and operate is a real estate brokerage office, which includes leasing, listing, purchasing, referral, selling, trading and other services of a similar nature under the trade name "Sellstate." We also sell Area Representative Rights to certain qualified individuals. The Area Representative has the right to sell franchises in certain territories, but is not a party to the franchise agreement. The Area Representative may also provide some services to the franchisee, but does not provide management of the Area.

The total investment necessary to begin operation of a Sellstate Franchise is from \$114,200 to \$389,000. This includes \$20,000 that must be paid to us upon signing the Franchise Agreement.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, us or our affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this Franchise Disclosure Document.

You may wish to receive your disclosure document in another format that is more convenient for you.
