Seniors Helping Seniors, LLC offers franchises that provide non-medical personal services such as in home elderly care, home assistance, companion care, transportation, homemaking and maintenance and repair to senior citizens and is currently expanding into personal-care services. We also offer area development rights to franchisees to develop and operate additional Seniors Helping Seniors Businesses within specific geographic areas.

The total investment necessary to begin operation of a Seniors Helping Seniors franchise is \$86,785 to \$141,390. This includes \$45,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or any affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.
