The franchise you will operate will be either (1) a SHAPES BROW BAR®, a beauty bar specializing in complete eye makeovers including brow shaping using the art of threading, brow tinting, lash design, lash extensions, lash tinting, limited general makeover services and facial hair removal, as well as retailing a limited number of beauty care products including our current lines REEMA BEAUTY and RMLA, or (2) a full service makeup, makeover and beauty care business selling multiple product lines and services under our RMLA™ brand (both referred to as the “D&D Beauty Businesses”) In RMLA’s, areas providing the eye makeover services will carry our SHAPES BROW BAR® brand for the services, and areas providing the makeup and makeover services will carry our s h a p e s Makeover Bar™ brand for the services In certain limited circumstances, you may be permitted or required to operate under the s h a p e s Makeover Bar™ mark or the alternate mark, SHE BAR®

In addition to services you will offer under our SHAPES BROW BAR® and s h a p e s Makeover Bar™

brands, RMLA Stores are larger and can offer some or all of the following additional services (1) makeover and beauty care services including skin care, hair styling (excluding coloring and cutting) and nail care services, (2) makeup application and makeover services, (3) body hair removal using waxing, (4) facial and beauty enhancement services including eyelash extensions and brow and eyelash tinting, and (5) demonstration and retail sale of samples, cosmetics and hair care, skin care, nail care and beauty products including our REEMA BEAUTY™ and RMLA™ cosmetic and beauty line Actual services and products offered at any particular D&D Beauty Business will depend on the format, local market conditions and landlord restrictions

D&D Beauty Businesses may be operated in either a kiosk format or inline store format

The total investment necessary to begin operation of a SHAPES BROW BAR in a Kiosk Format is from \$63,150 to \$81,600 This includes between \$23,500 and \$26,500 that must or will be paid to the franchisor The total investment necessary to begin operation of a SHAPES BROW BAR in an Inline Format is from \$129,250 to \$201,750 This includes between \$33,900 and \$41,900 that must or will be paid to the franchisor The total investment necessary to begin operation of a RMLA in a Kiosk Format is from \$68,600 to \$92,200 This includes between \$27,500 and \$31,500 that must or will be paid to the franchisor The total investment necessary to begin operation of a RMLA in an Inline Format is from \$178,500 to \$286,250 This includes between \$47,900 and \$61,200 that must or will be paid to the franchisor The amount that must or will be paid to the Franchisor may be less if multiple franchises are purchased in the same transaction and multiple purchase discounts or employee discounts to the Initial Franchise Fee apply, or if the franchisee is converting its existing substantially similar beauty care business to a D&D Beauty Business The total investment to purchase area development rights is \$7,000 per D&D Beauty Business required to be developed, all of which will be paid to the franchisor Franchisees will not be required at this time to make any payments to the franchisor's affiliates, unless the franchisee purchases an existing, operating D&D Business from an affiliate, or subleases the premises of the D&D Beauty Business from an Operating Affiliate
