SHAPES® Clubs are fitness businesses which focus on women's only fitness and offer women focused group training, individual, personal training and other fitness products and services we may designate or approve. The franchises offered are for the operation of a SHAPES® Club or Area Development franchise (multiple SHAPES® Clubs).

The total initial investment necessary to begin operation of an individual SHAPES® Club ranges from \$175,000 to \$612,000. This includes \$87,000 to \$312,000 that must be paid to the franchisor or its affiliate.

The total initial investment necessary under the Development Program of 2 to 3 SHAPES® Clubs ranges from \$215,000 to \$682,000 for the Development Program, including the cost of one SHAPES® Club, and the Franchise Fees due for each SHAPES® Club under the Development Program. This includes \$127,000 to \$382,000 (based on 2 to 3 SHAPES® Clubs) that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your Franchise Agreement, and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payments to the franchisor or an affiliate in connection with the proposed franchise sale or area development rights sale. Note, however, that no government agency has verified the information contained in this document.

SPOUSES MUST SIGN THE PRINCIPAL OWNERS GUARANTY AGREEMEMT BECOMING JOINTLY AND SEVERALLY LIABLE FOR ALL DEBTS OF THE FRANCSHIEE.

5. THERE MAY BE OTHER RISKS CONCERNING THE FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
