The franchise offered is for a SHARPS MD® Business that offers medical waste removal, compliance and disposal services and related products and services that we authorize from time to time.

The total initial investment necessary to begin operation of a SHARPS MD® Business ranges from \$95,425 to \$948,400. This includes \$35,000 to \$400,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. 2. THE FRANCHISE AGREEMENT STATES THAT FLORIDA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
