You will operate a full-service restaurant that features crab and other seafood and also offers salads, burgers, side items, other menu items, and soft drinks and that provides full bar service under the SHELL SHACK trade name and business system ("SHELL SHACK[®] Restaurant" or "Restaurant").

Currently, it is our policy to award only multi-unit development rights; franchisees who are new to the system must commit to develop at least two Restaurants according to the terms of our development agreement. The total investment necessary to develop your first SHELL SHACK[®] Restaurant under a two-Restaurant development agreement ranges from \$588,500 to \$858,900. This includes the \$35,000 to \$102,400 that must be paid to us or our affiliate, depending on whether or not you are opening your first or subsequent Restaurant and depending on which of the initial fees are imposed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
