Shield Security Systems businesses specialize in the sale, installation, servicing and monitoring of residential and commercial alarm systems and also intercoms, access control systems, closed circuit television, GPS tracking systems, home theater systems and central vacuum systems as incidental services.

The total investment necessary to begin operation of a Shield Security Systems franchise is from \$77,325 to \$127,500. This includes between \$49,600 – \$52,920 that may be paid to the franchisor or affiliate.
