The franchised business is a trailer-themed events rental company that provides modern photo booths and mobile bars in vintage-style trailers, under the trade name "Silvercloud Trailer Events".

The total investment necessary to begin operation of a Silvercloud Trailer Events franchise is \$138,700 to \$204,000. This includes \$90,000 to \$90,700 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
