We also offer to qualified franchisees the right to develop multiple Japanese Noodle Bars up to three (3) Restaurants under a Multi-Unit Agreement.

The total investment necessary to begin operation of your Restaurant is from \$367,150 to \$500,150. This includes \$42,950 that must be paid to us. The total investment necessary to begin operation under a Multi-Unit Agreement is from \$397,150 to \$560,150. This includes \$72,950 to \$102,950 that must be paid to us.
