The estimated initial investment required for a Sir Grout<sup>®</sup> business ranges between \$74,145 and \$119,780 This includes between \$50,750 and \$51,750 that must be paid to the franchisor or affiliate The fee associated with an Area Development Agreement is not included in this calculation
