  - 2. The franchisee cannot waive any rights. See Minn. Rule 2860.4400J. A court will determine if a bond is required. Amend accordingly.
- ✓3. Receipt page. Please supply a box or line by the sellers names to be able to indicate which person sold a particular franchise.
  - 4. Due to the deficit ratio of current assets to current liabilities in the franchisor's most recent audited financial statement, the franchisor will be required to comply with one of the following as a condition of registration:
- Impound initial franchise fees in a bank located in Minnesota until the franchised business opens. Submit 3 original signature Minnesota Impoundment Agreements;
  2 will be returned to the applicant for the Impound Agent and the Franchisor.
  - b) Post a Minnesota Surety Bond; amount is the initial franchise fee times the number of franchises projected to be opened in Minnesota (Item 20 in Franchise Disclosure Document). A minimum of one is required.
  - c) Defer payment of initial franchise fees until business opens; amend Franchise Disclosure Document (Items 5 and 7) and agreement(s) accordingly.
