As a franchisee, you will operate a Sitting Made Simple referral and placement service agency which will recruit service providers and provide referrals and placements of such providers for babysitting, child care, pet care, tutoring, and other general services to its subscribing members.

The total investment necessary to begin operation of a new Sitting Made Simple franchise is between \$49,649 to \$64,249. This total investment includes a minimum amount totaling \$39,500 that must be paid to the franchisor or an affiliate.
