Skin Type Solutions® Franchise System, LLC awards licenses (franchises) for the operation of a low cost educational and science-based retail non-traditional franchise named Skin Type Solutions Stores (Displays) that exclusively sell Skin Type Solutions Approved skincare products. Skin Type Solutions Displays are located within an existing business (a miniaturized retail business in another business) with a “just in time” inventory solution in order to create a new profit center, without materially increasing fixed and variable costs of the host business. Each Franchisee also receives at no cost an on-line internet selling site operated by our exclusive product distributor selling skincare product refills/reorders. Skin Type Solutions Displays are found in medical aesthetic offices such as a dermatologist, plastic surgeon, or medical spas and high-end spas, beauty salons, health clubs, and other appropriate businesses with sufficient financially qualified clientele.

The total investment necessary to begin operation of a Skin Type Solutions franchised business ranges from \$17,800 to \$32,500 (see Item 7 for details). This includes a \$7,500 initial franchise fee that must be paid to the Franchisor.

2. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN MIAMI, FLORIDA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN MIAMI, FLORIDA THAN IN YOUR OWN STATE.
