STS Retail Stores are located within an existing primary business to create a new profit center. Each Franchisee also receives at no cost a Patient Mobile App. Online Store fulfillment services are provided by our exclusive skincare product distributor. STS Retail Stores are found in medical aesthetic offices such as a dermatologist, plastic surgeon, or medical spas and high-end spas, beauty salons, health clubs, and other appropriate businesses with sufficient financially qualified clientele.

The total investment necessary to begin operation of a Skin Type Solutions franchised business ranges from \$8,000 to \$25,500 (see Item 7 for details). This includes a \$7,500 initial franchise fee that must be paid to the Franchisor.

2. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN MIAMI, FLORIDA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN MIAMI, FLORIDA THAN IN YOUR OWN STATE.
