Skyhawks businesses offer sports-related and other child development programs in a class, camp and party format using a variety of skill-based games for children from ages three to 16 years old (“Skyhawks Business(es)”)

The total investment necessary to begin operation of a Skyhawks franchise is between \$23,300 and \$67,675. This includes between \$14,000 and \$42,925 that must be paid to us or our affiliates.
