



The franchise is for Smoothie Factory Stores offering primarily non-alcoholic, fruit-based “smoothie” beverages, frozen yogurt, fresh-squeezed juices, health foods, coffees, teas, and vitamin and nutritional supplements.

The estimated initial investment ranges from \$153,950 to \$254,200 for a Smoothie Factory Store and \$47,500 to \$132,500 for a Smoothie Factory Express Store. This includes the \$25,000 initial franchise fee (\$6,250 for Smoothie Factory Express Store 500 sq. ft. or smaller) that must be paid to us or an affiliate.

This Franchise Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully.
