The franchise that we offer is for a Snapology business that provides curriculum based courses and programs that offer hands on learning experiences and events using Lego® brand bricks, K'Nex® brand toys, their substitutes and other building toys, robotics and animation techniques (the “Snapology Business”) Snapology Businesses may be established and operated as either a mobile only business where the Snapology Business is operated from temporary locations within a designated territory (a “Mobile Snapology Business”) or as a Mobile Snapology Business that also maintains and operates a fixed discovery center (a “Mobile Snapology Business Plus Discovery Center”) (Mobile Snapology Businesses and Mobile Snapology Businesses Plus Discovery Centers are individually and collectively referred to as “Snapology Businesses”)

The total investment necessary to begin operation of a Snapology Business that is only a Mobile Snapology Business ranges from \$35,100 to \$55,000 This includes \$24,000 that must be paid to the Franchisor or Franchisor’s affiliate for the initial franchise fee

The total investment necessary to begin operation of a Mobile Snapology Business Plus Discovery Center ranges from \$70,000 to \$165,000 This includes \$24,000 that must be paid to the Franchisor or Franchisor’s affiliate for the initial franchise fee
