The franchisee will operate a branded entertainment hair care salon business focusing on the specific hair care, spa services, and entertainment (including birthday party) needs of children, operating in buildings that bear our custom interior and exterior trade dress (the "Snip-its Salon").

The total investment necessary to begin operation of a single Snip-its Salon franchise ranges from \$125,850 to \$206,800. This includes \$27,500 that must be paid to us or our affiliates. \$25,000 of this payment is the single Salon initial fee.

In addition to offering a single franchise agreement, we also offer a "3-Pack Agreement" or "5-Pack Agreement," where you will sign three or five franchise agreements (respectively) simultaneously, with certain modifications to address the timeline for opening those Snip-its Salons. Your estimated total investment necessary to begin operation at each of the Snip-its Salons under a 3-Pack Agreement or a 5-Pack Agreement will range from \$115,850 to \$198,467. This includes \$19,167 (under a 3-Pack Agreement) or \$17,500 (under a 5-Pack Agreement) that must be paid to us or our affiliates. \$16,667 of the 3-Pack Agreement is part of the total initial fee of \$50,000 for a 3-Pack Agreement, and \$15,000 of the 5-Pack Agreement is part of the total initial fee of \$75,000 for a 5-Pack Agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Risk factors:

- 1. THE FRANCHISE AGREEMENT PERMITS THE FRANCHISEE TO MEDIATE AND LITIGATE ONLY IN THE STATE IN WHICH THE FRANCHISOR MAINTAINS ITS PRINCIPAL PLACE OF BUSINESS. THE FRANCHISOR IS CURRENTLY LOCATED IN MINNESOTA. OUT OF STATE MEDIATION AND LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO MEDIATE OR LITIGATE WITH THE FRANCHISOR IN ITS STATE THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT THE LAW OF MINNESOTA GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
- 4. LOCAL LAW MAY SUPERSEDE THESE FRANCHISE AGREEMENT PROVISIONS. CERTAIN STATES REQUIRE THE SUPERSEDING PROVISIONS TO APPEAR IN AN ADDENDUM IN THIS DISCLOSURE DOCUMENT (SEE EXHIBITS J AND K).

We may periodically use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchises. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
