The franchise offered is for the operation of a casual dining pub concept that serves lunch and dinner, and features hand-crafted burgers made from fresh angus beef, sandwiches, fried fish, and appetizers, plus beer, wine, and specialty drinks, including signature Bloody Mary cocktails and other alcoholic and non-alcoholic beverages and more (a “**SOBELMANS PUB & GRILL® Restaurant**” or “**Restaurant**”).

The total investment necessary to begin operation of a SOBELMANS PUB & GRILL® Restaurant ranges from \$447,000 to \$1,908,000. These totals include an initial franchise fee of \$45,000 and an initial training fee of \$10,000 that must be paid to us.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
