Soccer Shots Franchising LLC offers franchises for a youth soccer education program marketed to children ages 2-8 primarily through daycare centers, preschools, parks, and other community programs

The total investment necessary to begin operation of a Soccer Shots franchise is \$35,584 - \$48,100 This includes a \$29,500 Initial Franchise Fee plus up to \$1,725 that must be paid to the franchisor or an affiliate

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale **Note, however, that no governmental agency has verified the information contained in this document**

- 4 YOUR TERRITORY IS NOT EXCLUSIVE. SOCCER SHOTS AND ITS AFFILIATES RESERVE THE RIGHT TO OFFER SERVICES AND PRODUCTS THROUGH ALTERNATIVE CHANNELS OF DISTRIBUTION (SUCH AS INTERNET, TELEMARKETING AND OTHER DIRECT MARKETING), THROUGH ANY DISTRIBUTION METHOD. SOCCER SHOTS OR ITS AFFILIATES MAY ESTABLISH, REGARDLESS OF WHETHER THE OFFERING OF PRODUCTS OR SERVICES IN THE OTHER CHANNELS OF DISTRIBUTION COMPETE WITH YOUR FRANCHISED BUSINESS.
- 5 FAILURE TO ACHIEVE THE MINIMUM PERFORMANCE STANDARD CAN RESULT IN THE TERMINATION OF THE FRANCHISE AGREEMENT OR A REDUCTION IN THE SIZE OF YOUR TERRITORY.
- 6 THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
