We offer franchises for the operation of businesses that provide music classes for children newborn to six years old (“Songs for Seeds franchise”).

The total investment necessary to begin operation of a single Songs for Seeds franchise is \$91,300 to \$116,100. This amount includes \$73,400 to \$78,300 that must be paid to the franchisor. If you become a Multi-Unit Developer, you may elect to open two Songs for Seeds franchises or three Song for Seeds franchises. The total investment necessary to begin operation of two Songs for Seeds franchises ranges from \$162,600 to \$174,400. This amount includes between \$126,600 to 136,600 that must be paid to the franchisor. The total investment necessary to begin operation of three Songs for Seeds franchises ranges from \$233,900 to \$313,300. This amount includes between \$174,900 to \$189,900 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **NOTE, HOWEVER, THAT NO GOVERNMENTAL AGENCY HAS VERIFIED THE INFORMATION CONTAINED IN THIS DOCUMENT.**

You may wish to receive your disclosure document in another format that is more convenient for you. The terms of your contract will govern your franchise relationship. Don’t rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor like a lawyer or an accountant.

Please consider the following **RISK FACTORS** before you buy this franchise:

**1. The franchise agreement requires you to resolve disputes with us by mediation, arbitration or litigation only in New York. Out of state mediation, arbitration or litigation may force you to accept a less favorable settlement for disputes. It may also cost you more to mediate, arbitrate or defend a lawsuit in New York than in your home state.**

**2. The franchise agreement states that New York law governs the agreement. New York law may not provide the same protections and benefits as your state law. You may want to compare these laws.**

**3. The franchisor requires spouses of franchise owners to sign a personal guaranty together with the franchise owners, making each of them liable for the franchisee's obligations whether or not they are involved in the operation of the franchised business. This requirement places the personal assets of the franchise owners and their spouses at risk.**

**4. The franchisee will be required to make an estimated initial investment ranging from \$91,300 to \$116,100. This amount exceeds the franchisor's members' equity as of December 31, 2015, which is (\$68,898).**

**5. There may be other risks concerning this franchise.**

We may use the services of one or more **FRANCHISE BROKERS** or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
