Southern Maid franchises produce and sell donuts, rolls and other bakery products, non-alcoholic beverages and other items customarily sold in donut shops.

The total investment necessary to begin operation of a Southern Maid franchise is from \$66,500.00 to \$234,500.00. This includes \$5,000.00 that must be paid to the franchisor.

This disclosure document summarized certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
