Spa810 franchisees operate businesses offering cosmetic laser and skin services and the sale of related products and services to the general public ("<u>Single Unit Franchise</u>" or "<u>Spa810 Franchise</u>"). Spa810 regional developers ("<u>Regional Developers</u>") market and provide support services to Single Unit Franchises in the Regional Developer's designated area ("<u>Regional Developer Franchise</u>").

The total investment necessary to begin operation of a Spa810 Single Unit ranges from \$250,800 to \$600,900, including between \$242,150 to \$332,800 that must be paid to the Franchisor or its affiliates.

The total investment necessary to begin operation of a Spa810 Regional Developer Franchise ranges from \$54,150 to \$384,000, including \$50,000 to \$350,000 that must be paid to us. Franchisor strongly recommends, but does not require that Regional Developers open a Single Unit Franchise (a "Pilot Location"). The total investment necessary to begin operation of a Spa810 Regional Developer Franchise with a Pilot Location ranges from \$259,950 to \$939,900, including between \$247,150 to \$637,800 that must be paid the Franchisor or its affiliates.

The disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least fourteen (14) calendar days before you sign a binding agreement with, or make a payment to the franchisor or an affiliate in connection with the proposed franchise sale.
