SPA 810 businesses provide cosmetic laser and skin services, aesthetics, and massage to the general public and sell related products and services (“SPA 810 Business(es)”).

The total investment necessary to begin operation of a SPA 810 franchise is from \$359,700 to \$531,500. This includes between \$45,300 and \$68,300 that must be paid to the franchisor or its affiliates. If you purchase more than one (1) franchise at the same time as your first franchise, the estimated investment for each additional franchise is the same as the first franchise, from \$359,700 to \$531,500. This includes between \$45,300 and \$68,300 that must be paid to the franchisor or its affiliate(s) for each additional franchised business.

The disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make a payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT-OF-STATE ARBITRATION/LITIGATION/MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE/LITIGATE/MEDIATE WITH US IN ARIZONA THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT STATES THAT ARIZONA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. YOUR SPOUSE MUST SIGN A DOCUMENT WHICH MAKES YOUR SPOUSE LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT, EVEN THOUGH YOUR SPOUSE HAS NO OWNERSHIP INTEREST IN THE BUSINESS.
