You will operate a Sparkle Wash International Cleaning Service, a mobile, self-contained, power cleaning, restoration and preservation system for commercial, residential and industrial use

The total investment necessary to begin operation of a Sparkle International franchise is \$77,950 00 (trailer mounted) - \$103,950 00 (van mounted) for an exclusive franchise and \$82,950 00 (trailer mounted) - \$108,950 00 (van mounted) for a non-exclusive franchise. The total amount payable to the franchisor and/or its affiliates is \$63,450 (trailer mounted) - \$91,450 00 (van mounted). This includes the \$20,000 00 franchise fee and the \$43,450 00 (trailer mounted) - \$71,450 00 (van mounted) equipment cost that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale.
