Spice Wing Franchise, LLC ("Franchisor") offers franchises for the operation of a fast casual restaurant featuring the sale of chicken wings, boneless wings, chicken tenders, sauces, as well as other products. Spice Wing Restaurants offer on-premises dining, delivery and carry-out. Spice Wing Franchise, LLC has offered franchises since September 2017.

The total investment necessary to begin operation of a Spice Wing franchise is an estimated \$288,400 - \$656,500. This includes an estimated \$25,000 - \$29,000 that must be paid to the Franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
